Bylaws

Another important set of documents are the proposed changes to the bylaws. In July, a draft of the proposed bylaws changes was circulated for member feedback. To keep the process moving, member responses were due in August.

Although the initial comment period has closed, these documents are still

available for your review on the AAUW Texas website.

Since August, the bylaws committee has been working to incorporate the feedback it received. Texas was one of the top 10 states in providing comments to the committee.

Based on the feedback, the committee revised the proposals. The revised proposals will be in the Spring *Outlook* and should be on the Association website in January.

After you have read the material, then I hope you will have the courage it takes to stand up and speak.

Speak to your branch and district representatives and other state board members about what you think is the right direction for AAUW.

I encourage you to discuss and debate the proposals. Regardless of whether you agree or disagree, please respect member's opinions, as every member's goal is to find the right direction for AAUW.

Convention

Save the date and start setting aside funds (both branch and personal) to attend the convention in St. Louis. If you cannot attend, consider supporting other branch members financially.

Notice that the convention runs from roughly noon Friday to noon Sunday – much shorter than in the past.

For those attending the convention, bylaws briefing meetings are included on the schedule to provide the delegates with even more information and to answer questions.

Texas is a large state with many branches and active members. Our voices are critical in shaping the AAUW of the future.

Ann Richards Fellowship Approved

The American Fellowships program, the oldest and largest of the AAUW Educational Foundation's fellowship and grant programs, dates from 1888 when Vassar graduate Ida Street, a pioneer in the field of early American Indian history, received \$350 to pursue a graduate degree in education at the University of Michigan.

For 2008-2009, more than 1,100 eligible women applied for American Fellowships. However, the almost \$2 million awarded provided fellowships to only 97 women.

The AAUW Educational Foundation Board approved Texas' request to establish the Ann Richards American Fellowship. The fellowship has 15 years to reach the American Fellowship level of \$200,000.

When the Ann Richards American Fellowship is completed, it too will become part of the long history of women supporting women to achieve their academic and professional goals.

Branches with EF funds not directed to complete a fellowship, or research and projects grants, can direct those funds to the Ann Richards American Fellowship.

Branch Educational Foundation Vice Presidents will be receiving the information for how to direct funds to this new fellowship.

Do You Share Your Passion for AAUW?

Many AAUW Texas members suffered major economic setbacks during the past two weeks. Today, a friend spent most of the day with her financial planner trying to pick up the pieces of what she had considered a secure retirement. An email arrived from an AAUW baby boomer. She was getting her resume ready in search of a job to replace the one that she thought she would retire from in a few years.

Last week a student affiliate came to me and said, "Mo, I won't be able to continue next semester as I have been told that my work hours will be cut and that financial aid will not be available."

Yet, in the middle of this crisis, you read this message from me,

"Members you must get out and recruit members! Branches, you must retain the members you have!"

This is the time that current and potential members need the support of your branch. Women's equity may suffer in this environment as the competition for jobs and credit soar.

How can we market our mission to potential and current members when we are facing such an economic crisis?

Passionately live our mission, "AAUW advances equity for women and girls through advocacy, education and research."

Passionately share our value, "By joining AAUW, you belong to a community that breaks through educational barriers so that all women have a fair chance."

Passionately inform potential members that we have a very strong voice in government and actively lobby policy-makers on critical women's issues.

We also provide a powerful network of friends, advocates, and professional contacts both within branches and online. This is an organization of activists and during this type of economic environment; we need each other to promote the well-being of women.

Passionately emphasize that AAUW provides the lifelong learning necessary for our members to develop both professionally and personally.

Branch programming improves the quality of life and provides opportunities to develop skills and knowledge that will aid in career decisions.

How can we ask members who are suffering in this economic downturn to pay the dues for membership?

If a branch integrates membership development into everything that they do as a branch and if you intertwine membership with programming then you will provide the means to offer new members a lower dues rate through the **Shape the Future** Membership Campaign.

By promoting your program or event in the community, through media, event posters, community calendars, or collaborative partnership announcements you can then offer half-price memberships to individuals who **join at the event**.

The following rules apply:

Discounts are restricted to new or lapsed members (those who have not been members for at least two years). This discount applies to Association dues only, reducing the cost from \$49 to \$24.50.

You must use the Shape the Future guest/referral list so that staff can capture all the necessary information and the list **must** be turned into Association within two weeks of the event. You can download this form from the website.

Each branch will receive one free membership for every two members recruited on the spot.

A new member can choose to join a branch, or join as a member-at-large or as a MAL and state member. Even if they join only the Association, the branch still receives credit for the free membership.

There is a maximum of three free memberships each fiscal year. Use the free memberships to help those members or potential members who may be struggling through this crisis.

A new program provides free studentaffiliate memberships to

undergraduate students enrolled in a college or university that is a C/U partner. Check with your branch membership VP or state membership VP if you need more information concerning this program.

Every member of AAUW is a member of the branch's membership team. When asked why they joined most members respond, "Because I was invited by a friend." Share your passion for AAUW by calling a friend or even an acquaintance and tell them about AAUW.

Good News: The National Science Foundation Grant for our National Girls Collaborative Project has been renewed to begin January 1, 2009.

The *Every Member Poll* results found that members think highly of AAUW. Seventy-six percent were either satisfied or very satisfied. Eighty-four percent agree or strongly agree with the statement, "AAUW provides an articulate and respected voice on women's issues." Sixty- seven percent agree or strongly agree that AAUW effectively addresses all aspects of equity for today's women.

Board Meeting Highlights

The 2008-2010 AAUW Texas Board of Directors held its first meeting of the biennium in Austin on July 18-20, 2008. Between meetings, the board conducts business by email.

The Board of Directors voted:

- To adopt the strategic plan for 2008-2010.
- To adopt a balanced budget for the fiscal year 2008-2009.
- To apply to the Foundation to start a new American Fellowship in the name of Ann Richards.
- To reduce the number of printed issues of the UWT! and to use electronic distribution for the remaining issues.
- To modify who can be appointed to serve as nominating committee chair to allow the president to appoint a chair.

AAUW Texas Adopts Strategic Plan

The AAUW Texas Board of Directors began work on the strategic plan at the July Board meeting and refined the plan before final adoption via email in October.

Goal 1: Increase visibility of AAUW's mission and issues

AAUW Texas will increase the visibility of AAUW's mission and issues by:

- 1.1 Hosting a state convention in April 2010 to educate attendees on AAUW's mission, programs, and issues.
- 1.2 Educating our members regarding AAUW's programs that can be implemented at the branch or interbranch level and how to use these programs to increase visibility.

- 1.3 Increase visibility of AAUW Texas' public policy with its members, elected officials, and the public through advocacy and education.
- 1.4 Educating our members on the newest Educational Foundation research and how to use this research to increase visibility.
- 1.5 Collecting information and sufficient funds to start an Educational Foundation, American fellowship in the name of former Texas Governor, Ann Richards.
- 1.6 Educating our members regarding the changing role of the Legal Advocacy Fund and the continued need for financial support.
- 1.7 Educating ourselves and our members regarding Leadership and Training Institute.

Goal 2: Communicate effectively

AAUW Texas will communicate effectively by:

- 2.1 Communicating with branch counterparts using *the Link* at least quarterly, but more frequently as needed.
- 2.2 Communicating with branch members and state MALs using a concise and focused every-member publication (*UWT!*).
- 2.3 Communicating with branch members, state MAL's, and the public using the AAUW Texas website.
- 2.4 Communicating with Association regarding routine business and bylaws changes.

Goal 3: Expand and diversify membership

AAUW Texas will expand and diversify membership by:

- 3.1 Highlighting programs or structures in branches that successfully expand membership.
- 3.2 Continuing to actively support all branches, especially the development of newly formed branches and those working to on revitalization.

- 3.3 Educating ourselves, branches, and state MALs on how supporting LTI can impact membership.
- 3.4 Developing strategies to target diverse members, through branch and state recruitment efforts.

Goal 4: Identify, develop and provide opportunities for leaders

AAUW Texas will identify, develop and provide opportunities for leaders by:

- 4.1 Providing leadership opportunities for AAUW Texas members.
- 4.2 Sponsoring a leadership conference in July 2009.
- 4.3 Creating a Student Advisory Council.
- 4.4 Educating members about alternative branch structures at the leadership conference in July 2009 and/or state convention in April 2010.
- 4.5 Identifying and recognizing branch projects, programs, or processes that develop and/or nurture leaders.

AAUW received consultant status with the UN. This is a great "feather in our cap" and allows us to be even more visible and effective in our work at the UN and in international affairs. Convention on the Elimination of All Forms of Discrimination Against Women is still an important resolution. The Senate must approve it.

Foreign Relations Committee. Let's keep up the pressure to get it passed. The United States is among about eight countries that have not ratified. Others include such stellar countries as Iran, Qatar, Tonga, Sudan, and Somalia!

Pay Equity: Please call both of your federal senators and ask them to vote for SB1843, the Senate version of the Lilly Ledbetter Act.

Pilot Projects. Two completely voluntary projects will be initiated in the next few months. One is the national dues collection project only for those who wish to send their membership this way. The other is a local scholarship clearinghouse. Again, BOTH OF THESE ARE VOLUNTARY.
