

AAUWTEXAS CONVENTION WILL NOT CONSIDER ANY BYLAWS AMENDMENT UNLESS PROPOSAL COMES FROM THE FLOOR.

At the 2006 Texas State Convention, the membership approved recommendations from the Restructuring Taskforce. This included multiple changes to the state bylaws. We are in the first biennium of these changes and no major problems have arisen. With these recently updated bylaws and no proposals received this year, the bylaws committee did not convene and did not propose any changes to be considered by the membership at the upcoming convention in Dallas .The AAUW Texas Bylaws do allow for bylaws amendments and resolutions to be proposed from the convention floor. Unless proposals come from the convention floor, the convention will not consider any bylaws amendments in Dallas.

NOMINATIONS MAY BE MADE FROM THE FLOOR

In additions to this slate presented, the AAUW Texas bylaws allow the nominations may be made from the floor of the state convention provided that the written consent of the nominee has been obtained.

The convention will honor 100 Texas Women of Distinction, past and present, and hear of the work of women for the advancement of women across the state and beyond

A preconference tour on Friday, April 25, will visit the *Nasher Sculpture Gardens and the Women's Museum.* Be sure to register early for this "don't miss" event.

FRIDAY- The opening session will feature Colleen Barrett, President of Southwest Airlines as the keynote speaker. Past presidents of AAUW-Texas will also be recognized.

SATURDAY AND SUNDAY will be a blend of **general sessions**, **district meetings**, **workshops and panels**. According to AAUW Texas Program Vice President Lane Powell, the workshops and panels will address five key subject emphases related to the general theme:

Investing in Leadership Development Investing in Economic Security and Opportunity;
 Investing in Educational Success and Opportunity; and
 Investing in our Sisters of the World.

Saturday's luncheon and dinner are included in the registration fee and feature the work of the Educational Foundation of the Association and the Legal Advocacy Fund. A birthday celebration will also highlight the dinner event.

On Sunday morning, a breakfast meeting will recognize the 100 Texas Women of Distinction who have been nominated by branches across the state. A new convention feature, a Graduate Research Poster Session, will highlight the work of university graduate students in the Southwest who are addressing issues of interest to the enlightenment and advancement of women.

"How appropriate that graduate students' work will be featured, considering that AAUW is one of the world's largest sources of funding for graduate women," said AAUW Texas President Linda Conger. In the 2007-08 academic years, the Educational Foundation provided more than 250 fellowships, grants, and special awards to outstanding women.

WORKSHOPS-TRACKS

In keeping with the 2008 Biennial Convention theme, "Celebrating 100 years in Texas and investing in the Future," convention workshops will focus on several aspects of future investment for the advancement of women. Each convention registrant will have three workshop choices for the Saturday and Sunday programs. The workshops will follow five different aspects of "investment in the future" of women and the AAUW TX organization:

TRACK ONE-Leader Development

- Building Membership
- Mental Health Promotion in College and Community

Options will include an Orientation session for new officers; a session on Building Membership, and a session on Mental Health Promotion in Colleges and Community. The last topic is a result of a new partnership with the Texas Suicide Prevention Council which seeks to educate the public about the high incidence of depression and suicide among women and particularly college women. "By learning the signs of depression and suicidal thoughts, women can better assist one another in finding pathways to health and happiness," explained program vice president Lane Powell. "We strongly urge every college and university in Texas to send a representative to this session."

TRACK TWO Economic Security and Opportunity

- Maximizing your Resources
- Financial Exploitation of Elderly
- Opportunities for Entrepreneur

Deena Katz

For the **Economic Security and Opportunity** track of sessions, **Dr. Deena Katz**, internationally recognized financial advisor and a member of the Personal Financial Planning department at Texas Tech University will offer pointers on maximizing your Resources. Dr. Katz is author of six books on financial planning and practice and has been named repeatedly as one of *Accounting Today*'s Top Ten Names to Know in Financial Planning." A second session targeting Financial Exploitation of the Elderly will be presented by **Shannon Cox**, Private Investigator with the Probate Law section of the Dallas Area Paralegal Association. Ms. Cox has handled some high-profile cases of exploitation and will advise women on how to avoid such financial hazards. A third session led by **Dr. Maxine Hammonds-Smith**, university professor, author and entrepreneur, will give tips on how to start a successful business. Dr. Hammonds, who lives and teaches in the Houston area, is currently national president of the National Council on Family Relations.

TRACK THREE- Promoting Pay Equity for Woman and Equal Pay Day

• Behind Pay Gap Program Research by AAUW-EF

In keeping with the ongoing emphasis of AAUW on **Equity in the Workplace** and recognizing that "Equal Pay Day" is also in April, a panel discussion on Equity issues will be offered during the Saturday afternoon workshop sessions. **Malinda Gaul**, San Antonio attorney and former state president of AAUW, will share the podium with **Kathy Miller** and **Judge Lynn Cherry**. Miller, President of the Texas Freedom Network, keeps a close watch on state legislative issues that affect women's rights. Cherry, who has had a private practice in Family Law since 1986, was elected Judge of the 301^a Family District Court in November 2006. She is completing her first year in this position.

TRACK FOUR-The Education Success and Opportunity

AAUW Programs


A review of successful AAUW association-sponsored programs, led by **Jackie Littleton**, a member of AAUW Texas and the Association Board. She will discuss ways the National Girls' Collaborative and the National Conference for College Women Student Leaders (NCCWSL) can be sponsored and supported in your community. A new feature-- a research poster session-- will highlight the graduate student research in women's issues that is currently occurring in universities in Texas and surrounding states. Student authors of the posters will be present on Sunday, April 27, to discuss their findings with participants.

Read the AAUW Education Foundation's <u>Behind the Pay Gap</u> research—Just 1 year after college graduation, women earn only 80 percent of what their male counterparts earn. Ten years after graduation, earnings are only 69 percent of what men earn.

TRACK FIVE -Sisters of the World

- Opportunities for minority women and girls in Texas
- Financial exploitation of the elderly
- Opportunities for Entrepreneurship

The fifth track of workshops focuses on **Sisters of the World**, and will offer unique and personal glimpses into the lives and challenges facing women of color and of diverse cultures. A panel addressing issues of women and girls in Texas will feature Dr. Alice Black, Dr.



A second session of this track will feature **Dr. Hind Jarrah**, a founding member and current President of the Texas Muslim Women's Foundation. A native of Beirut, Lebanon, Jarrah has a PhD in pharmacology from the University of Texas Health Sciences Center in Dallas. Dr. Jarrah is highly regarded as a speaker on the topic of Issues Muslim Women Face, and she has worked to correct misconceptions that build bonds of friendship and understanding between cultures.

A final session, to be offered Sunday morning, will be led by AAUW Texas International Relations chair **Karen McKibben Morris**. She and others will review some of the successful international outreach programs promoted by AAUW, including the new partnership with CARE International and the Friendship tours which have brought Russian women visitors to several Texas communities.

WOMEN OF TEXAS ARE MAKING HISTORY



KEYNOTE-FRIDAY

Colleen Barrett, President and Corporate Secretary of Southwest Airlines (SWA), will keynote the opening session of the 2008 AAUW Texas biennial Convention on Friday night, April 25.

A member of the management team of the Dallas-based airline since 1978, Barrett literally rose through the ranks to assume the presidency of one of the most efficiently run airlines in the country in 2001. She was named one of the World's 100 Most Powerful Women in 2004 and 2005 and won the Outstanding Woman in Aviation Award in 2007. Her lengthy list of honors and awards include Girls' Inc honoree (2007), the Horatio Alger award (2005) and the Aiming High award from the National Organization of Women. Barrett is active in numerous civic and charitable organizations in Dallas, serves on the Boards of Trustees of JC Penny, Inc, the Ken Blanchard College of Business and Becker College, Worchester, MA. her alma mater.

Ms. Barrett represents the kind of competency, vision and initiative that women of Texas need to emulate in the 21st century," said AAUW Texas President Linda Conger.

"We are delighted to celebrate 100 years of advancement of women in Texas with such an outstanding model."



DR LAURA GONZALES FACILITATOR FOR SISTERS OF THE WORLD

A 2005 recipient of the American Jewish Congress Southwest Region's "Women of Spirit Award," Dr Laura Gonzales is widely recognized for her civic leadership and work with students. A Research Scientist in the School of Social Sciences at The University of Texas at Dallas, she has been recognized as the 2004 "Distinguished University Faculty Award" by the Texas Association of Chicanos in Higher Education.



Dr. Gonzalez has served as a Counselor for the Mexican communities of North Texas, representing issues and concerns as an advisor to the Government of Mexico.

Laura's passion is serving people and helping them both through personal mentoring and by connecting them with key community leaders in area agencies, organizations, and institutions of higher education. That passion is channeled through community research about Latino educational issues that has been published in a number of national scholarly journals and reviewed by the Civil Rights Project at Harvard University.
