## convention keynote speakers

**Ivy R. Taylor** was elected Mayor of San Antonio on June 13, 2015. Prior to that, she was appointed to the office of Mayor in July 2014, to fulfill Julian Castro's unexpired term. She had served as the District 2 City Council Representative for a total of five years beginning with her election in June 2003.

Mayor Taylor served on the board for Healthy Futures of Texas and Big Brothers Big Sisters of South Texas. She has served on the City's Planning Commission and as a Commissioner for the City's Urban Renewal Agency (SADA). Mayor Taylor completed the Leadership San Antonio class sponsored by the Greater San Antonio Chamber of Commerce, and in 2004 was acknowledged by the San Antonio Business Journal as a "Rising Star" in their "40 under 40" class.

Mayor Taylor obtained a Master's Degree in City and Regional Planning from the University of North Carolina at Chapel Hill in 1998. In 1992, she received a Bachelor's Degree from Yale University. Mayor Taylor is a devoted wife and a mother.



**Chief Justice Sandee Bryan Marion** was elected in 1992 as Judge of Bexar County Probate Court No. 2 where she served until her appointment to the Fourth Court of Appeals in 2002. In 2014, she was elected to serve as Chief Justice of the Court.

Chief Justice Marion graduated with honors from the University of Texas at Austin in 1977 and from St. Mary's University School of Law in 1980. After law school, Chief Justice Marion practiced law with Hollon & Marion in Boerne, Texas. In 1985 and until her election to the Probate Court bench, she was a partner with the San Antonio law firm of Goode, Casseb and Jones. She is board certified in Family Law by the Texas Board of Legal Specialization.

In 2008, Chief Justice Marion was named Distinguished Graduate of St. Mary's University School of Law. She is a past President of the Board of the St. Mary's Law Alumni Association. Chief Justice Marion is an active member of the Rotary Club of San Antonio and served as the first woman President of the Club in 1998-1999. Chief Justice Marion has served on the Texas Pattern Jury Charge Committee for Probate and Guardianships since 2010. She is also the immediate past Co-Chair of the San Antonio Bar Association's Community Justice Program.

Chief Justice Marion is married to Homero R. Garza, M.D. and they reside in San Antonio.



## convention keynote speakers



**Representative Ina Minjarez** was elected to serve the constituents of Texas House District 124 after a quick special election. During her 30 days at the Capitol, Ina accomplished a great deal for hardworking Texas families. Though she couldn't write legislation, she served as an important swing vote in the House Committees on Transportation and State Affairs, helping block bad bills and pass good ones.

By the end of the 84th Legislative Session, Ina had joint-authored 17 bills, co-authored 45 bills, sponsored or joint-sponsored 8 bills, and the Governor signed 5 of these bills into law.

Ina was born and raised in El Paso, Texas by two hardworking parents with deep roots in social justice. From an early age, Ina and her sister were taught that hard work and education would lock open the doors of opportunity. She was awarded several academic scholarships to attend the University of Notre Dame, where Ina wrote about social justice issues and traveled to serve the underprivileged and the oppressed. She picked crops with migrant workers and interned in the office of an El Paso attorney who helped migrants and refugees file for legal residency.

After graduation, Ina attended St. Mary's Law School in San Antonio. During her studies, Ina interned with the Bexar County Criminal District Court Administration. Ina has had a successful career prosecuting defendants charged with crimes against children. Later, Ina opened her private practice, and represented children who were victims of abuse and neglect in Child Protective Service cases. Ina has also represented workers in employment law disputes and on-the-job injuries.



**Rebecca J. Viagran** was elected to City Council District 3 in May 2013 and re-elected to the office in 2015. Viagran is proud to be from a family whose history extends over 200 years in San Antonio and South Texas, and has a long legacy of service to the community she currently serves. She resides in the same neighborhood where she grew up while attending St. Leo's Catholic School and Providence High School. After high school, Viagran attended Texas State University where she received a Bachelor of Science Degree in Geography - Urban and Regional Planning. Desiring to make an impact in San Antonio city

government, she returned to her hometown after graduating from college to work as a city council aide. Her focus was working with neighborhood associations and constituent services. She takes pride in serving the constituency that helped nurture, form, and educate her.

Aside from being directly involved with city government, Viagran also has experience working with community organizations and volunteering for important causes. She served the San Antonio Hispanic Chamber of Commerce as Vice President of External Affairs and worked as the Director of Government and Community Relations for Mexicans and Ameri-

cars Thinking Together (MATT).

Volunteerism has played a central role in Viagran's career path. Affected by the events of September 11, she volunteered in New York City at Ground Zero. She also worked as an international missionary in Spain. Leadership development and issues concerning women and children have always been important to Viagran. She has served on the board of directors of Voices for Children-San Antonio and was appointed to the Mayor's Commission on the Status of Women.

Viagran earned a Master's Degree in Public Administration from St. Mary's University and taught as an adjunct professor in Political Science. She also assisted in maintaining her family's small business, established by her parents in 1966 in District 3.

Viagran serves as Chair of the Council's Criminal Justice, Public Safety, and Services Committee, and she currently sits on the various council committees. In 2013, Viagran identified a need to foster and nurture the future leaders of District 3. During her first term in office, she implemented the first-ever student leadership program known as the District 3 Legacy Leadership Initiative (D3LLI) for high school and college level students. The mission of the program is to introduce the future generation of young leaders in District 3 to a network of community leaders in order to cultivate education, knowledge, and exposure towards civic engagement. To date over 30 leaders have graduated from the D3LLI program.

**Sarah Davis** is a three-term Texas state representative. Davis graduated from John Foster Dulles High School in Sugar Land in 1994. In college, she was a member of the Baylor University debate team. After receiving a Bachelor's Degree in Economics from Baylor in 1998, she went on to earn her Law Degree from the University of Houston in 2001.

Davis is an accomplished and successful attorney devoting her career to defending against personal injury lawsuits. She is a partner with the national law firm of Wilson Elser, LLP. Sarah's clients include individuals, local businesses, and Fortune 500 companies.



Davis was first elected to the Texas House of Representatives in 2010, and served on the Public Health and Judiciary & Civil Jurisprudence Committees. Davis was re-elected in 2012 and 2014, and currently serves on the House General Investigating and Ethics, Public Health, Calendars, and Appropriations committees. She served on the appropriations subcommittee dealing with health and human services, and also chaired the appropriations subcommittee on budget transparency and reform. This past session, Speaker Straus selected Representative Davis to serve as a conferee on the budget conference committee, as 1 of 5 house members charged with reconciling the house and senate budgets. She was also recently named to the House Select Committee on Mental Health.

**Linda D. Hallman, CAE** is the chief executive officer of AAUW. For more than 25 years, Hallman has made her mark as an association innovator. She has led a variety of associations, focusing on creating high-performance individuals, teams, programs, and governance in the fields of health care and horticulture. Before taking the helm of AAUW, Hallman served as president and CEO of the American Medical Women's Association. From 1997 to 2002 she served as CEO of the American Horticultural Society, and from 1988 to 1997 she held virtually every leadership position with the American College of Health Care Administrators. Hallman began her career as a soprano soloist with the United States Army Band, "Pershing's Own," at Fort Myer, Virginia.

A native of Washington, D.C., Hallman received her bachelor's degree in music education from Indiana University in Bloomington, Indiana, and her master's degree in organizational management from George Washington University in Washington, D.C. She is also a certified association executive (CAE). Hallman is a frequent speaker on women's issues, finance, leadership, and management, and she's an expert on creating extraordinary membership experiences and cultures, organizational strategies, alliance building, and fundraising. In 2013, she was recognized as one of 100 Women Leaders in STEM by STEMConnector.

Hallman lives with her husband and her standard poodle in the Washington, D.C., metropolitan area, where she maintains a personal commitment to what close friends call her "exquisite" garden.



**Toni Johnson** is the vice president of major and planned giving at AAUW. Her nonprofit development career began as youth director for the American Red Cross in Haholuku, Hawaii, where she was born and raised. She is committed to making a difference and believes that organizations are only as good as the people in them.

Toni brings a wealth of development and management experience and expertise to AAUW. Over the past 25 years she has worked as executive director for the American Red Cross, the American Diabetes Association of Greater New York, and Anderson House (a halfway house for women in recovery in New Jersey) and served as northeast regional development director for Food Allergy Research and Education (FARE). She lives with her husband in Old Town Alexandria, Virginia, and has two grown children. Toni loves the beach, sunshine, travel, and the gym.

**Jackie Littleton** is a long-time member of AAUW and has held offices in branches in Oregon and Tennessee, as well as her current Tyler branch. She served as secretary of the national board and as president of AAUW in Tennessee. She is currently Funds chair for the Tyler branch and a member of the national Legacy Circle team.

A retired teacher, Jackie is also a published author.



As a successful CEO, business leader and government official with a 30-year career in both the private sector and public service, **Hope Andrade** has delivered value in a variety of organizations and environments from corporate to fast-growing startups to government agencies. She is a highly respected senior government official, public servant and community leader who brings a private sector business perspective to her government roles, and a government understanding to the private sector. Hope's vast network of public, private and government connections has enabled her to be extremely effective at opening doors, bringing the right people to the table, and building public/private partnerships to pave the way for business growth for companies at the local and state level. She has built strategic alliances and deep relationships with senior government leaders, foreign dignitaries, and business leaders across geographic and cultural settings, overcoming obstacles and driving successful outcomes for domestic and international business alike.

From July 2008, to November 2012, she served as Texas' longest serving Secretary of State and was the first Latina to hold this role. She resides in San Antonio with her husband, Ramiro, of 47 years. She is the co-founder of the recently formed Andrade-Van de Putte and Associates, a consulting agency.

**Leticia Andrade** is Executive Director of Human Resources for CST Brands, one of the largest independent retailers of motor fuels and convenience merchandise in North America, located in San Antonio, TX. CST Brands currently employs approximately 14,000 employees with nearly 1,900 locations throughout the United States and Eastern Canada. As Executive Director, Leticia plans and oversees the HR critical workflow for mergers and acquisitions to include HR due diligence, management of multiple human resource programs, and the development and execution of integration plans to align HR processes enterprise-wide.

Prior to joining CST Brands, Leticia worked as an Assistant Visiting Professor at the University of Texas at San Antonio, teaching in the College of Business. With 18 years of experience in a variety of

human resource leadership roles, Leticia has worked in several industries such as health care, professional services, hospitality, and education.

In 2015, Convenience Store News named their Top Women in Convenience and Leticia was a recipient of the "Rising Star" award. Also in 2015, Leticia was nominated and accepted to the Fortune Magazine's Most Powerful Women- Next Gen conference in San Francisco.

Leticia earned a Bachelor's Degree in Spanish and with a minor in Mathematics from the University of Texas at Austin, a Master's Degree in Business Administration from Saint Mary's University, and a Doctorate of Philosophy in Business Administration with a specialization in Organization and Management Studies from the University of Texas at San Antonio.

## PROPOSED BYLAW CHANGES

At the AAUW Texas 2016 Convention, there will be a vote on proposed bylaw changes submitted by the Bylaws Committee and branches. You can find a complete copy of the bylaws showing the following: (1) mandatory changes from AAUW national in blue and (2) proposed changes to be voted on in red on our website - <https://aauw-tx.aauw.net/>.

The rationales for the changes are: Article IV, Section 3.a.(4)(c) to clarify that every branch member in the State of Texas must be a member of AAUW Texas; Article IV, Section 5.d. is proposed for deletion since AAUW is no longer affiliated with IFUW; Article V, Section 1.a. is proposed to increase the pool of members available to serve as chair and alternate chair of the nominating committee; and Article XVI, states the current applicable law.

The changes in Article V, Section 2 and Article XIII, are proposed to conform AAUW Texas voting with AAUW national One Member One Vote.

## PROPOSED AAUW TEXAS STATE DUES INCREASE

For more years than many of us can remember, annual AAUW Texas State dues have been:

- AAUW Texas State Dues (including Paid Life Members): \$10.00
- AAUW Texas Undergraduate Student Affiliate Dues: \$1.00
- Honorary 50 Year Life Members (AAUW members for 50 years, plus): \$0.00

After a review of the current economic trends & the increased cost of simply doing business, the 2014-2016 State Board is proposing a \$3.00 per member increase in state dues beginning with the 2017-2018 membership year. The reasoning behind this increase:

- Everyday rise in operational expenses
- Increased state-wide visibility efforts and marketing which leads to branch growth
- More effective network with like-minded organizations on a state level thereby increasing AAUW's visibility
- Increasing benefits and incentives offered to smaller more rural branches in the area of mission based programming, onsite leadership training, team and branch rebuilding support
- Increase in requests for State support & sponsorship of AAUW programing on College/University Partners campuses in cities where there is no AAUW Texas Branch, (ex: ElectHer, TechSavvy)
- Efforts to assist & support the formation of new branches in areas where there were once thriving AAUW branches
- Recruitment of Colleges/University Partners where branches do not or no longer exist & provide support & assistance to branches in reaching out to Colleges/Universities to become C/U Partners
- The ability of the AAUW Texas State Board to more effectively 'give back' to our branches

**AAUW and AAUW Texas State Dues Structure in 2017 would become:**

- National Dues: \$49.00
- 2017-2018 AAUW Texas State Dues (including Paid Life Members): \$13.00
- AAUW Texas Undergraduate Student Affiliate Dues: \$1.00
- AAUW Honorary (50-year) Members: \$0.00
- Individual Branch Dues: varies (see individual branch structure)

This dues change must be voted on by the AAUW Texas membership at the 47th Biennial State Convention, April 30, 2016 Business Meeting along with the proposed AAUW Texas State Bylaws revisions.

## BRANCH DELEGATES

Each branch must elect an appropriate number of delegates based on its size. Our guidelines for determining the number of delegates that each branch is entitled to have is based on the AAUW Texas Bylaws, Article XII, Meetings of AAUW Texas:

Section 2. Voting Body or Representation,

a. The voting body of the state convention shall consist of duly elected and verified delegates, the members of the Board of Directors, all past AAUW Texas presidents, college/university representatives and National members who are members of AAUW Texas.

c. Each branch shall have three votes and, in addition, there may be one vote for every ten members of the Association above the first ten or major fraction thereof. Each branch shall apportion its votes among the elected delegates.

Student affiliates, in addition to dual members of the branch, count toward the branch membership totals that will be submitted to the State Finance Officer, **Inés Garcia** after February 1, 2016.

The State Finance Officer will soon be sending all branch presidents specific instructions regarding procedures necessary for branches to follow in order to ensure that branch delegates receive the proper credentials at the 2016 State Convention.
